

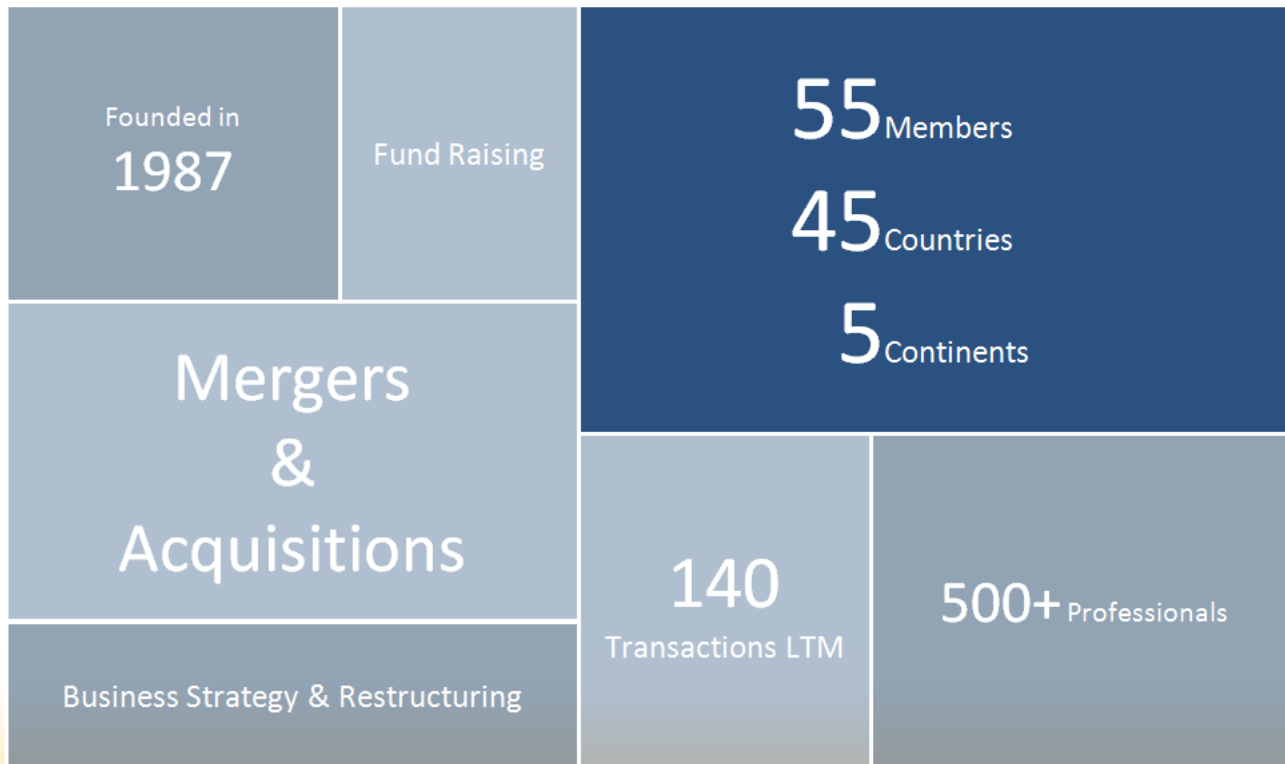

Globalscope also hosts regional events within Europe, Asia, and the Americas, to nurture deal discussions specific to geographical mandates.

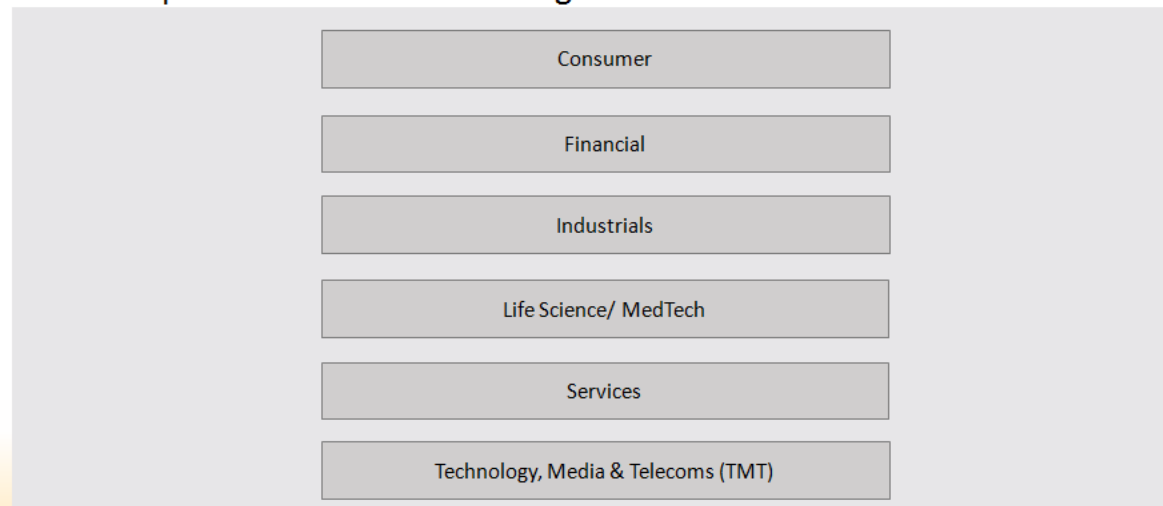

The Globalscope Family Legacy

- 1987 Foundation of American Corporate Services (ACS)
- Early 90s Foundation of International Conculancy Network (ICN)
- 2005 Merger of ACS and ICN into one international network of M&A advisors
- 2006 Creation of Globalscope name and brand
- 2010 Globalscope has 20 members on all continents
- 2014 Merger with Asia M&A Group, adding 9 new members in Asia to the network
- 2016 Globalscope has 45 members in 37 countries
- 2019 Globalscope expands to 55 firms in 48 countries
